THE SUSAN HARWOOD GRANT ENABLED JSI TO PROVIDE FALL PREVENTION FOR RESIDENTIAL CONSTRUCTION WORKERS. TRAINING TOPICS FOCUSED ON THE MOST COMMON TYPES OF FALLS IN CONSTRUCTION INCLUDING FALLS FROM LADDERS, SCAFFOLDS, ROOFS, TRUSSES, AND STEEL ERECTION. THE TARGET AUDIENCE INCLUDED NON-LITERATE, LOW-LITERATE, OR LIMITED ENGLISH PROFICIENCY WORKERS, AND FOCUSED ON WORKERS IN SMALL BUSINESSES.
